### Early Years Foundation Stage (EYFS) reforms 2021:

'Steady Steps Nursery and Pre-school delivering an ambitious curriculum that brings learning to life'

In September we introduced a new approach to delivering our Early Years Curriculum and how we record observations and assessments of children in our care. These changes were in response to the reforms of the Statutory EYFS and have enabled us to plan a curriculum that is tailored to each child, taking account of their interests, emotional literacy, disposition to learning and stage of physical development; all key elements in the successful progression of young children.

Our approach also emphasises the importance of and allows for more time for quality interactions and teaching, this was only achievable by reducing the amount of paperwork each member of staff was expected to complete for each child.

We are in the process of producing a Parent/Carer leaflet to explain Steady Steps Early Years Curriculum, this will be sent out towards the end of term. In the meantime, if you have any concerns regarding your child's learning, development and or care needs please arrange to see Julie Pickthall or your child's Key Person.

#### Covid-19 Measures of mitigation and control:

A detailed document explaining our measures of control are available via your Tapestry account. This document is reviewed as and when deemed necessary in response to local and or Government guidance. We also have to make changes in response to what is happening in our setting and the number of positive cases being reported. We need to all work together and take a collective responsibility to ensure our setting remains open, this may mean making the difficult and sometimes disruptive decision to keep a child or staff member at home for a period of time. I cannot emphasise the importance of keeping your child at home if they are unwell, as we are experiencing in the Nursery this week, children who have been in lock down have not built up a natural immunity to everyday childhood illnesses and are readily contracting them from each other. This is despite our strict hygiene procedures; the enhanced cleaning regimes being carried out by staff during the day and the fantastic job our end of day cleaner carries out.


